About this Global Code Comparison

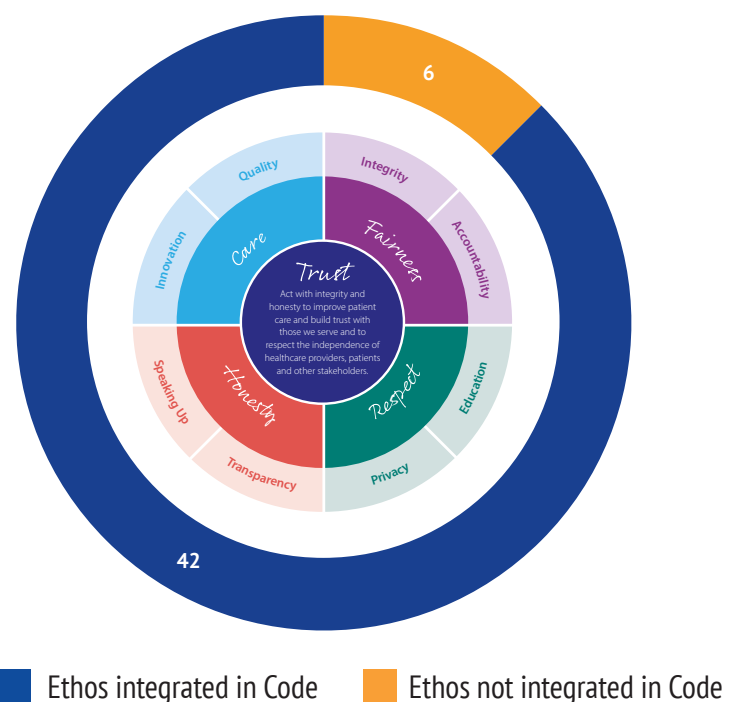
This Global Code Comparison table, initiated by IFPMA's Ethics & Business Integrity Committee (eBIC), is the collective feedback of IFPMA member associations and provides a general overview of national and regional associations' codes and their related provisions. All associations' input in this comparison is based on data collected between April – June 2020. This comparison table is a snapshot of the global research-based pharmaceutical industry's self-regulation mechanisms and the commitment of IFPMA members to the ethical promotion of medicines and interactions with healthcare professionals, patient organizations and medical institutions, for the safety and benefit of patients worldwide.

For the 2020 edition particular attention was paid to the IFPMA Ethos, which has been developed to facilitate the shift from a rules-based approach to a Code based on values and principles.

This chart represents the number of member associations that integrated the Ethos in their code, it does not include those associations that did not provide data.

It should be noted that the intention of this table is not to provide a comprehensive analysis of regional and national associations' codes. Therefore, the comparison table does not include a precise account of national codes' requirements, depth of coverage or additional provisions. The Yes/No answers provided in this comparison simply indicate whether or not a certain provision is, or is not, covered by the relevant code in question as benchmarked to the global IFPMA Code of Practice.
